The discharge occurred on December 27, 2020 for approximately 4 hours. The untreated wastewater entered into Little Crabtree Creek in the French Broad River Basin. The pump station was repaired and placed back into service by removing rain and ground water from the dry pit and restoring electrical service to the pumps to prevent further discharge.
