Kevin continued his exemplary driving career as an ice road trucker on the North Slope's Arctic oil fields, construction, and on Amchitka Island on the Aleutian Chain.

After working for 17 years with Allied Transport, transporting vehicles from the Port of Alaska, Kevin knew every mile post and frost heave between Fairbanks and Homer. He retired after 33 years driving for Teamsters Local 959.

In 1979, Kevin's wife and daughter joined him in Anchorage to visit for a few months, never returning to North Carolina. They built a life in Alaska through hard work and dogged determination. They spent a couple winter months each year traveling and visiting family. Their favorite adventures included hiking in Alaska and Sedona, Arizona.

They enjoyed several Caribbean cruises, visits to Hawaii, and driving cross country and up the Pacific Coast Highway.

Everyone's favorite memories of Kevin were fishing in Alaskan waters. Kevin captained fishing adventures out of Deep Creek, Anchor Point, Homer, Whittier, and Seward. Friends and family cherish memories of dipnetting on the Kenai River and Copper River filling their freezers with salmon for the long Winters. Kevin, known for his smile, warmth, and kindness will be missed by all.

Kevin, after his 7-month battle with lung cancer, joined his Heavenly Father and those who passed before him, including his father, Horace Daniel Ray Jr.
