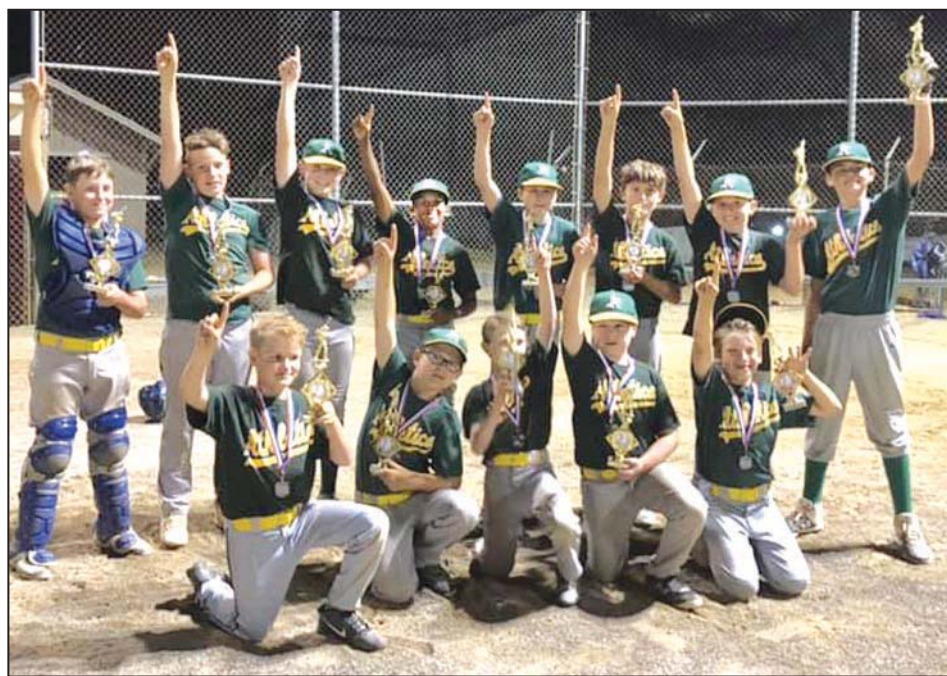




**Cherokee artisan at Super Saturday**

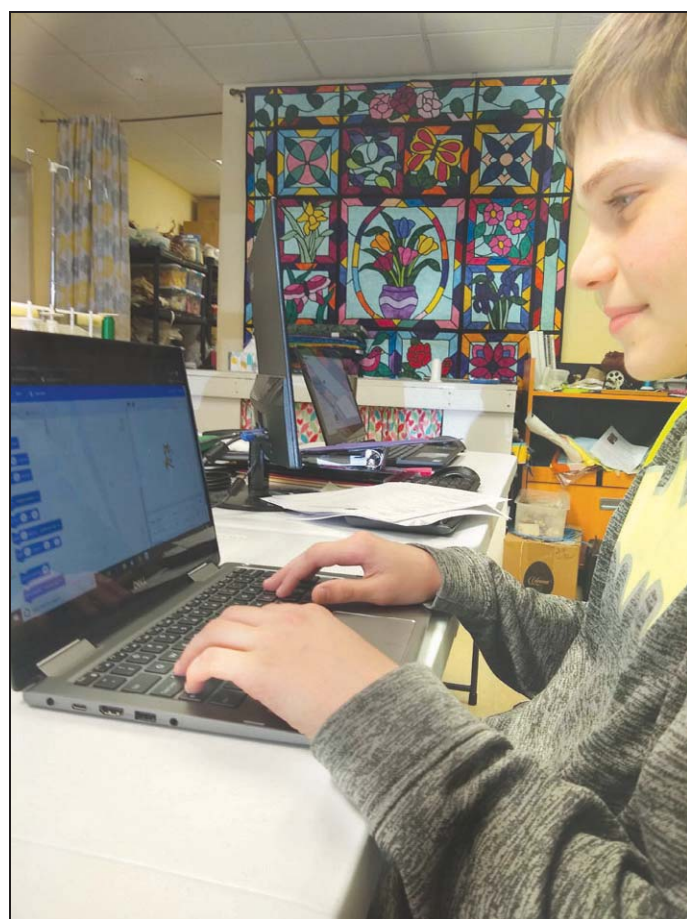

**Robotics and coding camps for kids ages 8 to 12 and 11-up**

Do you have a child that likes to tinker? Do you have a child that is glued to the computer?

Quilt-N-Code has several camps designed with just these children in mind.

In basic robotics, for children 8-12, children will build a robot and program it to draw shapes.

The Advanced Robotics camp, for children 11 and up, will build and program robots to hunt for mystery clues in tight spaces.

The robotics camps use Mindstorms Lego Robotics and Programming.

The Coding Camps will teach coding using Scratch. The kids will learn the basics of programming as they build a story or a game.

All Robotics and Coding camps are one to two weeks from 1-4 p.m.
