ADVERTISEMENT OF TAX LIEN ON REAL PROPERTY

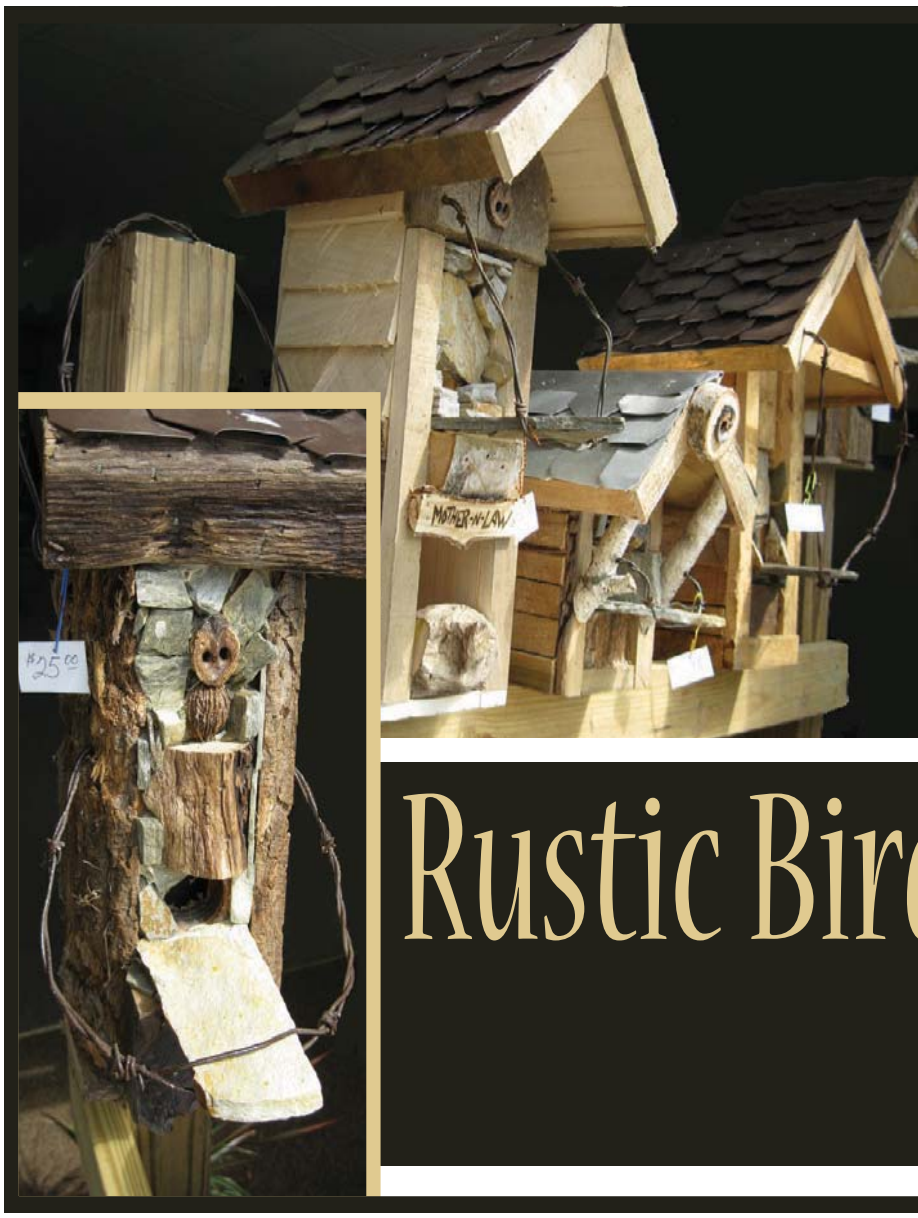
